From 25 July 2022, discretionary portfolio management services formerly provided to Allianz Technology Trust PLC (the "Company") by Allianz Global Investors ("AllianzGI") have been delegated to Voya Investment Management Co. LLC ("Voya IM"). All members of the former AllianzGI Global Technology Team transferred to Voya IM and continue to manage the Company's portfolio. It is anticipated that there will be no change to the investment process. AllianzGI will remain the Company's AIFM (Alternative Investment Fund Manager), providing company secretarial, administration and sales and marketing services.

Fund Manager's Review

The Allianz Technology Trust's NAV total return was -1.85% in August, compared to the Dow Jones World Technology Index return of -0.60%. During the month, stock selection and industry allocation modestly detracted from relative returns.

Contributors

Nvidia Corp. was the top contributor to relative performance during the month. Nvidia delivered very strong guidance that was solidly above investor estimates, despite high expectations. Strength was driven by tremendous growth for AI products and a supply chain that has ramped far more quickly than investors assumed. The Datacenter Compute segment grew 157% quarter-on-quarter, exceeding expectations by far and boosting confidence that AI demand should drive revenue and earnings growth for a protracted period. While the recent earnings results were a welcome boost to the portfolio, we are mindful of the recent strong run and the rise in valuation and trimmed the portfolio's position size in Nvidia during the month. We maintain conviction, however, in the company as a portfolio holding.

Amazon.com, Inc. was also a top contributor as the company delivered strong earnings results, driven by better-than-expected margin improvement in its North America segment. Management also noted the potential for more margin opportunity through further enhancements in its fulfillment localisation strategy, which cuts down on inventory touch points and travel distances. Additionally, AWS (Amazon Web Services) growth stabilised in the quarter, with management noting a shift in customer behaviour from cost optimisation to workload deployment. The company also sees additional growth opportunities in a slate of generative AI- enabled products that should drive demand over a longer horizon.

Other top relative contributors included an underweight position in Apple Inc., not owning Tencent Holdings Ltd. and an overweight to Arista Networks Inc.

Detractors

Datadog Inc. was a top detractor in the month of August. Datadog offers a cloud-based data monitoring and analytics platform which integrates and automates infrastructure monitoring, application performance monitoring and log management for real-time observability of customers. The company reported mixed second-quarter results as cloud optimisation headwinds impacted the business, which led to the company's full-year revenue guidance being cut. Management called out continued cloud optimisation challenges and elevated churn among its smaller customers. Despite the recent challenges, we remain positive on the long-term opportunity for Datadog, driven by secular tailwinds around data growth, the continued shift to the cloud, and increasing infrastructure complexity from the use of containers, microservices and generative AI.

Cybersecurity software provider, Fortinet, Inc., was among the top detractors in August after it delivered disappointing results, missing estimates on revenue and billings as the company saw the macro environment broadly impact customer buying behaviour. Fortinet cited weakness with large enterprise and service provider customers and due to digestion of purchases made in prior periods. As a result, full year guidance was lowered to reflect more conservative close rate assumptions and continued pressure in the macro environment. The company's results are likely a reflection of macro challenges catching up with the business once it has worked through its backlog of orders from prior periods and faces tougher comparisons. In our view, the long-term opportunity as a portfolio holding is still intact and the company's growth rate is likely to benefit from the scaling of the faster-growth non-FortiGate business over the medium term.

Michael Seidenberg received his BS in Business Administration from the University of Colorado in 1990. He received his Master of Business Administration from Columbia Business School in 1996 with concentrations in Finance and Accounting. Prior to attending Columbia Business School, Michael worked for Roche Laboratories (a division of Hoffman LaRoche) in pharmaceutical and biotechnology sales. From 1996-2001, he worked in the software industry in a variety of roles and spent time at Oracle Corporation. He began his investing career with Citadel Investment Group in 2001 covering the software space. Over the next 8 years he broadened his coverage list to include a variety of technology sectors. Prior to joining the Global Technology team in Sept 2009, Michael worked at a number of hedge funds including Pequot Capital and Andor Capital.

Other top detractors included overweight positions in Meta Platforms Inc., MongoDB, Inc. and Hubspot, Inc.

Market outlook

Our expectation is that the recent macro challenges could translate to an attractive opportunity for long-term investors as the technology sector is likely to continue benefitting from secular tailwinds which should drive capital appreciation over time. Having said this, we are cognisant of the scrutiny on IT budgets and the potential challenge near term. In addition, many companies remain challenged to find workers to meet customer demands and are likely to further leverage technology-based solutions to improve productivity of limited staffs. As companies need to reduce costs and improve productivity, particularly in light of a potentially uncertain macroeconomic outlook, we expect to see accelerating demand for innovative and more productive solutions such as cloud, software-asa-service, artificial intelligence, cyber security, etc. Lastly, we are excited about the advancement of artificial intelligence and what it means to the companies who trial and embrace these new models. Like many secular themes in technology, we would expect the companies who both enable and benefit to have good long term revenue growth and profitability characteristics but caution investors to expect volatility in this emerging sector. This is yet another example of technology solving a difficult problem and providing companies with a competitive advantage over time. We are in a period of rapid change, where the importance of technology is key to the prosperity of most industries. We believe that this environment is likely to provide attractive growth opportunities in many technology stocks over the next several years.

We continue to believe the technology sector can provide some of the best absolute and relative return opportunities in the equity markets — particularly for bottom-up stock pickers with proven long-term selection capabilities.
