Fund Manager's Review

Portfolio Overview

The Allianz Technology Trust's NAV total return was 3.7% in March, slightly underperforming the Dow Jones World Technology Index return of 3.8%. During the month, stock selection detracted and industry allocation contributed to relative performance.

Our position in electric vehicle maker, Tesla, was the top relative contributor. Shares surged during the period after the company officially opened its flagship European production facility in Berlin. Additionally, the company announced the board had accepted a proposal for a second stock split in two years prompting further share gains. We believe the near-term results could remain solid amid strong demand and ramping supply. We believe the world is now embracing EVs and the move toward sustainable transport has reached an inflection point. We also believe that Tesla is positioned to be a leader in this transition as it embraces continued rapid innovation.

Our position in security software vendor, CrowdStrike, was also a top relative contributor. The company is emerging as a leader in the next-generation endpoint security market. Shares gained after the company reported better than expected revenues and profits in the most recent quarter driven by strong momentum in new client sales and growth with current customers. Management also gave guidance that suggested strong growth and profitability would persist for the current fiscal year. We continue to believe CrowdStrike's endpoint security solutions are particularly relevant in the new distributed workforce context that many enterprises find themselves in today.

Other top active contributors included overweight positions in MongoDB and KnowBe4 and not owning Tencent.

Our position in Okta was the top relative detractor during the period. The company provides software that enables secure connections between people and technology. Shares came under pressure following the company's disclosure of a security breach that affected a small number of customers. In our view, Okta still has a significant opportunity ahead, targeting markets that are still in the early stages of penetration and with the opportunity to expand into adjacent markets. We believe the company is on a multiyear journey benefiting from massive tailwinds such as zero trust, digital transformation, and cloud transition.

Our position in cloud-based data storage and analytics company Snowflake was also a top relative detractor. The company reported strong quarterly financial results with 102% year-on-year revenue growth, but this fell short of elevated expectations. Snowflake had record bookings during the quarter and added another 14 Fortune 500 customers and 21 in the Forbes Global 2000. Snowflake has built a highly advanced cloud-

native architecture that represents a major leap over traditional analytical databases that have been in the market for decades. Our portfolio investment case remains that the company has a significant opportunity to grow for several years as it benefits from the cloud transition and the rising demand for cloud security solutions.

Other top active detractors included overweight positions in Micron and Seagate and an underweight position in Apple.

Market Outlook

In our view, the technology sector continues to benefit from strong tailwinds which, we believe, should continue to drive attractive long term appreciation. There is no question in our minds that the COVID-19 crisis will spur the use of technology and change how we live and work in the future. Additionally, many businesses are struggling to find workers to meet customer demand and need technology solutions to improve productivity of limited staffs. As companies need to reduce costs and improve productivity, we expect to see accelerating demand for innovative and more productive solutions such as cloud, software-as-a-service, artificial intelligence, cyber security, etc. We are in a period of rapid change, where the importance of technology is key to the prosperity of most industries. We believe that this environment is likely to provide attractive growth opportunities in many technology stocks over the next several years.


We continue to believe the technology sector can provide some of the best absolute and relative return opportunities in the equity markets – especially for bottom-up stock pickers.
